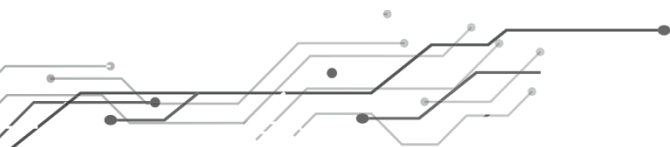

ADMISSION REQUIREMENTS



Admission into the Advanced Certificate (Precision Farming) is subject to the Admission Policy of Peritum Agri Institute, and in line with the requirements stipulated in the Higher Education Act (Act No 101 of 1997). The following minimum admission requirements apply:

- A Higher Certificate at NQF Level 5 in a cognate field of study, e.g. a Higher Certificate in Farming, Higher Certificate in Agriculture, or an equivalent qualification.
- Prospective candidates who have obtained a qualification [non-cognate] equivalent to higher certificate level or higher with two or more years agricultural production experience.
- Prospective candidates who obtained international qualifications equivalent to a Higher Certificate at NQF Level 5 may apply for admission, provided that they meet the minimum requirements for Advanced Certificate studies.
